RONALD MCDONALD HOUSE

Many of you are aware that TASBO has supported the Ronald McDonald House in the past and will continue to do so for future conference events. This past year's contribution, while generous, fell short of our conference goal . For this reason this article seeks to remind people of the benefits the RMHC provides to those in need so as to encourage more generous giving in the coming year.

In 1974, the first house opened in Philadelphia , PA. It was started by Fred Hill, a football player for the Philadelphia Eagles, and Dr. Audrey Evans. Mr. Hill's daughter had been diagnosed with leukemia and in gratitude of the care his daughter had received at St. Christopher's Hospital for

Children, he asked what he could do. Dr. Audrey Evans recognized the need for temporary residences for families to stay while their loved ones were being treated. Upon hearing of this need, Mr. Hill enlisted the support of the whole football organization, in addition to Ed Rensi, the regional manager for McDonalds and built a 7 bed facility near the hospital.

Today there are 300 Ronald McDonald Houses in over 52 countries. While McDonald's food chain is one of the charity's biggest sponsor, it is through the generosity of many organizations, like TASBO, that help this charity to continue to provide "homes away from home" for children and their families dealing with prolonged treatment.

MANAGING HYPERTENSION

About one in every 3 American adults suffers from high blood pressure or hypertension. The good news is high blood pressure can be treated and controlled.

Following the DASH (Dietary Approaches to Stop Hypertension) diet, developed by the National Heart, Lung and Blood Institute, has been shown to lower blood pressure enough to significantly reduce hypertension risk. To follow the DASH diet, add more fruits and vegetables to your plate gradually. Eventually make fruits, vegetables and grain products the main focus of your meal, while enjoying smaller amounts of meat, poultry and fish.

A nutrient-rich eating plan is a good idea whether or not you have high blood pressure. Consult your doctor or a registered dietitian for more information.

ROCKY BLEIER FOR 2011 CONFERENCE

FOUR TIME SUPER BOWL WINNER


Rocky Bleier's life story - a gripping tale of courage on both the football fields of America and the battle fields of Vietnam - has held audiences in rapt attention for years. Yet, the motivational message behind it, detailing how ordinary people can become extraordinary achievers, defines success in the new American century.

With the same optimism, sense of humor and steadfast determination that were his trademarks as a Pittsburgh Steelers running back, Rocky Bleier takes audiences from his early years through his professional career and talks about the lessons he learned along the way...lessons that we all can benefit from.

Not falling within the ideal of what a running back should look like, Bleier had to run harder and play smarter to be able to stand out. Despite his drive and ability to make the big play, the Pittsburgh Steelers only considered him a late round pick. But before the season ended that first year, he was drafted again...this time by the United States Army. At the height of the Vietnam War, Bleier was thrust into combat early and was seriously wounded when his platoon ran into an ambush. Receiving wounds from both rifle fire and grenade fragments in his legs, he was barely able to walk and his professional football career seemed to have ended before it began.

For more than two years, he drove himself. Little by little he overcame obstacles and fought his way back. He not only made the Pittsburgh Steelers, but also eventually became a starting running back on a team that won four Super Bowls and became the greatest football team of the 20th century.

The hard lessons Rocky Bleier learned early in his life that helped him overcome adversity and reach his goals, have paid off after football. Some of those lessons are seen between the lines in the popular book on his life, "Fighting Back," and an ABC-TV movie of the week by the same name.

403(B) NEWS

Over the past several months growing concern has been expressed over certain 403(b) plan administrators. As someone with the experience of going through two (2) IRS plan audits, it is imperative your plan administrator works for the school district and keeps you in compliance. The issue with some "free" administrators is they really want to sell new tax shelter annuities to the school district employees to pay for the plan administration to keep you in compliance. If this is occurring, then they are NOT a "free" administrator, nor a "Third Party Administrator" (TPA).

Concerns expressed regarding free 403(b) plan administrators are:

- Do we have a plan document that covers current IRS 403(b) plan regulations?
- Does our adoption agreement include all of our plan specifics?
- Are loans and distribution (if allowed) being processed correctly?
- Are payroll deductions and excess contributions monitored correctly?

If the school district is audited, will our "free" plan administrator get us through the IRS audit?

To address these concerns, I am entertaining thoughts of a statewide consortium for independent 403(b) services. We could get exceptional pricing and a multiple year price guarantee for independent TPA services.
